THE EARLY DANCE CIRCLE MISSION STATEMENT

The Early Dance Circle aims to promote the enjoyment, performance and study of early dance. Like "early music", the term "early dance" covers a range of historical periods. We aim to celebrate the dance of each of these, considered within their various contexts across Europe. We believe that the knowledge of earlier forms of dance helps to enrich the cultural life of the UK, by accessing an important international heritage that belongs to us all, but is now largely forgotten.

We aim to foster authenticity in the performance of early dance. Our members, amateur and professional, enjoy recreating the dances of all social settings (such as royal court & country house, street & tavern, theatre & opera), based on careful research and on detailed descriptions in original sources.

We also aim to help disseminate their work. Our members perform, study, teach and publish. As an umbrella organisation on behalf of early dance, the EDC sponsors a national Festival each autumn, an Annual Lecture each February and an academic Biennial Conference on aspects of early dance. The Proceedings of our Conference are published and speakers come from all over the world. We also publish a Directory of Regular Classes, our own Circular and a number of works in dance education & research. The EDC established the National Resource Centre for Historical Dance, now housed at Kellogg College, Oxford University.

Membership is open to all who wish to participate in or support early dance and have a desire to help safeguard and pass on its history in the UK, and internationally.

The maximum amount available for an EDC Grant is £3,000 in the first instance. Please be aware that the EDC only funds projects relating to European-based dance styles more than 100 years old
